Contributions for current tax year accepted through April 15 of following year

Your \$200 (single taxpayers), \$400 (married taxpayers) or any lower amount supports extra-curricular programs, sports, clubs, fine arts and field trips for students registered in a Payson Unified School District school. You choose where your contribution goes, then take the dollar-for-dollar tax credit on your AZ individual tax return.

- *Hand-delivered to any school or the District Office by April 15, or*

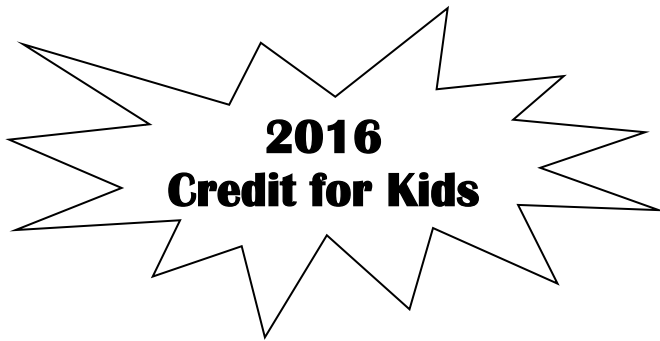
